

### **REGULAR MEMBERS**

Regular membership is limited to general contractors in the construction industry who have established a reputation for SKILL, RESPONSIBILITTY and INTEGRITY. A general contractor is defined as a construction firm owned and operated by an individual, partnership, corporation, or a joint venture who contracts to perform construction work in its entirety, and who executes such work, in whole or in part, with his own constructing force and equipment.

#### **ASSOCIATE MEMBERS**

Associated membership is limited to subcontractors who have established a reputation for SKILL, RESPONSIBILITY, AND INTEGRITY. A subcontractor is defined as any person, partnership, or corporation engaged in building construction and who, pursuant to subcontract, customarily furnishes labor, or labor and materials, for building construction projects at a job site.

# VISITNG MEMBERS

Visiting Members meet the same eligibility requirements as the Regular Members. This membership, however, is limited to general contractors who are working in the West Central Ohio area on a temporary basis.

# **AFFILIATE MEMBERS**

Affiliate membership is limited to those individuals, firms, or corporations engaged principally in the manufacture and/or sale of materials and/or equipment and/or services used by contractors engaged in construction and/or who employ personnel directly connected with the construction industry, or those who activities are related to the construction industry and have established a reputation for SKILL, RESPONSIBILITY, and INTEGRITY.
